2015 ALABAMA AGD GOALS

Each year as Editor, it is my duty and privilege to obtain photographs of the various MAGD, FAGD, and LLSR candidates at the National AGD meetings. They must appear before their award ceremonies for group pictures, as well as for individual shots which I can use in our Alabama Composite.

Often several awardees don't make it to the Region 19 photo-op, leaving me to search among the 300 or so cap-and-gowned folks for Alabama faces who have earned due respect in the Composite.

Sadly, at the 2014 AGD convention in Detroit, my job was easy. Why? For the first time in my 24 years as Editor, Alabama had no FAGD, MAGD, or LLSR candidates.

The Fellowship award requires 500 hours of approved CE, and a successful score on the Fellowship Exam. AGD provides plenty of support, including a study guide which one can order (also available online), and a two-day course offered at the summer national convention, as well as several options in the fall. All information needed to receive any of these awards must be submitted by December 31 of the year preceding the next convention.

Being awarded the Mastership requires 1,100 hours of approved CE. 400 hours must be earned in participation courses, and 400 must be in specific disciplines. Attendance at the AGD Annual Meeting Convocation Ceremony is required to be awarded these honors.

The best way to work on Mastership is through a Master-Track program. UAB offered an excellent one several years ago, providing the best CE I have ever received. Plans are underway to re-establish the Master Program at UAB now. Dr. Gordon Isbell is involved in this effort, and welcomes any comments at grisbell@isbelldental.com.

All you need to prepare for these awards is available at agd.org. Log on to the member site, and click on "Track your continuing education". You will find answers to all your inquiries. The following Plan of Action was developed:

- Develop a promotional ad for the Alabama Academy of General Dentistry for use in recruiting new members
- Promote advantages of the ADA
- Pinpoint volunteers from each district to make personal connections to ALAGD members who have not renewed their membership.
- Implement aid in programs to help young dentists find jobs
- Develop a five year program to enhance young dentists' professional lives

It was a great day for those in attendance and, as you can see, very beneficial for all of ALAGD. Please check your calendars, save the date, and come to our joint meeting this summer in Destin. We have a great lineup of speakers and a beautiful venue!





"Action for Dental Health" Day in Montgomery

On March 12, dentists from across Alabama journeyed to Montgomery for "Alabama Action for Dental Health." This annual event allows hometown practitioners to be informed by legislators of important actions afoot in our state government concerning our profession.

Also in attendance were some third-year dental students who were on Spring Break at the SOD. Many of those present were AGD members.

The proceedings began with a briefing on legislative issues. As Senators and Representatives were busy on the floor of the House and Senate at this time, we were not able to visit them personally, as had been planned.

Senator Paul Bussman, however, was kind enough to visit with the group, later joining us for luncheon at the RSA Building. Paul is a Dentist from Cullman, and has been an active AGD member for much of his career. What an important asset he is for our profession.

The highlight of the day's events was an update from Governor Robert Bentley. Our Governor spoke to us about his plan to obtain money to "beef up" the General Fund. He was adamant that as a conservative Republican Governor, he hated to raise taxes, but it is necessary in order to have the funds we need to keep our state moving forward.

His proposals include an automobile sales tax increase from 2% to 4%; an increase in the cigarette tax; and taxes on large corporations that are at this time being exempted. Whether the Governor will be successful in getting the tax bills through both Chambers of the Legislature remains to be seen.

Your Editor has participated in this event many times, and recommends that each of you consider attending next year. The more involved we are in actions which affect us personally, the better our opportunities to make a difference.

The book's newest edition, available online, includes information on:


- Goal setting

Online access to this second edition is free to AGD members. AGD student membership is only \$17 per year. Join the AGD to access the book and all of the great benefits of AGD membership!



AT THE BOARD MEETING FOUR PAST PRESIDENTS ALL IN A ROW.




Our ability to care for this particular population is largely due to the expert mentorship of our program directors and adjunct faculty—and we are always looking for more!


